Bus Queensland Conditions of Travel of Chaperoned or Unaccompanied Minors

1. It is against Bus Queensland Policy to carry children 11 years and under (inclusive) unless accompanied by a chaperone aged 16 years or over. A Parental Guardian Authorisation Form must be completed for all unaccompanied minors under the age of 14 years of age whether or not travelling with a chaperone or to or from a Boarding School.
2. Children 2 years and over will be charged the applicable child rate with a confirmed seat. Children under 2 years of age may travel free of charge if accompanied by a full fare paying adult. Should a child under the age of 2 years require a seat, the applicable child rate will be charged.
3. I, the undersigned, certify I am the parent or guardian of the above named minor(s).
4. I certify the minor(s) are to travel alone and agree to and request the unaccompanied carriage of minors.
5. I also agree to and accept that the following terms are the conditions upon which Toowoomba Transit Pty Ltd (ABN 83 135 249 062) agree to the unaccompanied carriage of the minor(s).
 - a) "a minor" shall mean a person who is no younger than 13 years and no older than 16 years.
 - b) "the carrier" shall mean and include Toowoomba Transit Pty Ltd, it's servants agents and employees.
 - c) The carrier accepts no responsibility for the protection, care (including medical care), custody, control and/or supervision, funds for food and/or general sustenance, of the minor(s) at any time or at any place, whether in transit or otherwise, including:
 - i. the place of departure.
 - ii. the place of destination and
 - iii. stopping places whether shown in the Carrier's timetable as scheduled stopping places or otherwise.
 - d) The carrier accepts no responsibility for injury and inconvenience of any kind whatsoever (including death, injury, delay or loss) arising out of, or incidental to any failure by the Carrier to protect, care for, control and/or supervise the minor(s), whether or not such injury or inconvenience be due to negligence on the part of the Carrier or otherwise howsoever, and the parent or guardian for him/herself, the minor(s) and their executors, administrators and dependants expressly renounces all claims
6. I confirm that I am responsible for any arrangements for the minor(s) to be accompanied to the place of departure and until the time of departure and for the minor(s) to be met and collected on arrival at the place of destination.
7. I authorise the Carrier to make any arrangements they consider necessary to ensure the minor(s) safe custody and well being at the time or place and I agree to indemnity and reimburse the Carrier for all of its costs and expenses incurred in undertaking such action. I understand that Clauses 5a), 5b), 5c) and 5d) above apply to this authorisation and that this authorisation taken by the Carrier pursuant to it are subject to those clauses.
